The gold-, silver- and tin-plated contacts are ideally suited for industrial automation requirements and the radial sealing elements provide IP67 sealing performance. TE's Circular Hybrid Connector is available with either hydraulic oil-resistant plastic enclosures or EMC protected metal enclosures and a turning catch-lock ensuring safe locking even in high shock (up to 25 g) and vibration environments.
