PCN OVERVIEW

- To better serve our customers, Molex will develop a second manufacturing location at Molex Bangalore plant, India for its Ten60 connector. In this initiative, Molex India will develop some additional tooling's from the attached part list, while using some components from the current manufacturing location - Molex Singapore. There may be changes in sourcing for raw materials and packaging materials.
- The entire process is expected to get completed by Mar-2027. The impacted PN will be supplied from 8204 plant apart from the existing Singapore location post implementation of this PCN. Molex will manage the transition schedule appropriately to ensure quality expectations are met while maintaining ongoing deliveries.
