■ Overview Description of Change:

- As a part of Molex's continuous effort to support our customer's demands, a transfer strategy for the MXP120 BLADE 1x2 & 1x6series will be relocated to Guadalajara, MX.
- Molex will transfer injection molds and assembly equipment from Chengdu, China with no impact to the fit, form & function.
- All materials related to this initiative will be strategically reallocated and sourced from existing suppliers, utilizing established material grades that are currently approved and available within the North American region
- The notification is due the Country-of-Origin change (China to Mexico).
- Guad sur plant will have all the demand for this series (AME, EMEA & ASIA).
- The part number affected: please see PN list attached.
- PPAP will be available upon request. Submissions will not occur without request.
- PCN will be implemented once all required qualification/validation has been completed, and all necessary approvals have been obtained.

■ Product Impact :

- The new tools will be validated by mechanical and sealing tests in the laboratory.
- Once approved, the new molds could be released and PPAP for mass production to Molex.
- No impact to packaging, DU or MLQ.
- No Impact to form, fit and function change.
- The change will be validated with DVPR and will be approved by OEM's.

■ General information:

- In accordance with the requirements established by the certifying bodies, the Guadalajara 2 facilities have IATF 16949:2016, ISO14001:2015, ISO45001:2018.
- All these part numbers are Molex proprietary designs, therefore considered catalog/general market product.
- In addition to the new manufacturing facility, we are working with a third-party logistics provider in Guadalajara, Mexico (DSV x Schenker its address is Carretera La Venta-Nextipac # 3020, Int 2C, Zapopan, Jalisco, Mexico 45220).
