Change Points & Descriptions

1. The tray shape: The tray shape will be changed as shown in the photo.
2. The polyethylene foam: The polyethylene foam will be removed.
3. Securing method: The securing method will be changed as follows:
 - Before: Cardboard on both the top and bottom, secured with three Mobilon bands.
 - After: Cardboard on the bottom only, secured with two Mobilon bands.

Packaging Change Overview

Reason for the Change:

The current tray does not fit the shape of the product and requires polyethylene foam to fill the gaps. Changing to a tray that matches the product shape will help ensure product stability during transportation. It will also reduce the use of packaging materials, such as polyethylene foam, and help address anticipated supply shortages.

Product Impact:

- There is no impact on the form, fit or function of the products.
- The products may slide slightly within the tray after the polyethylene foam is removed. However, no issues were observed during the drop test with the products packed in the tray, confirming that the new tray and packaging configuration are acceptable.
