Panduit has improved the design of Wire Basket Cantilever Brackets and Bottom Waterfalls.

Cantilever Brackets:

- Improved manufacturability with no impact to product performance.

Bottom Waterfalls:

- The new design increases bend radius from 1.5" to 2" to support small diameter fiber cabling.
- The new Wide Bottom Waterfall design increases width from 3.9" to 5" to cover entire grid opening.
- ~~Electro-Zinc finish is replaced with Pre-Galvanized finish for simplified supply chain.~~
