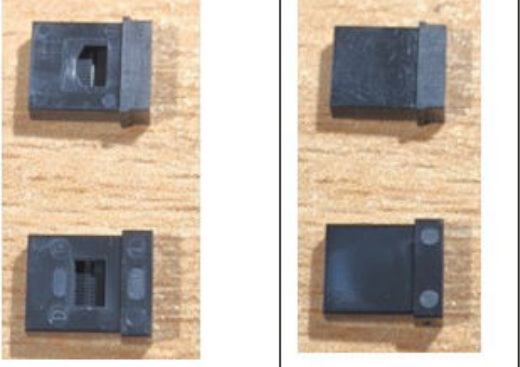

Replace the US Conec Elite ferrule with Senko low loss ferrule due to limited supply of US Conec low loss ferrule. Comparison testing showed the new Senko ferrules to perform equal to the US Conec ferrule. The new Senko ferrule meets the same testing performance as the US Conec ferrule. Interchangeability was tested and found to be acceptable.

6. Method of Identifying Change

Senko ferrule does not have the US Conec brand name marking. See pictures showing the differences between the ferrules visible to the Customer.
